Part A: Knowledge and comprehension	<ul style="list-style-type: none">• Multiple-choice Examination<ul style="list-style-type: none">» Learners are required to use one of the four standard assessments under examination conditions, which consist of 30 questions in a variety of formats that can be achieved within 45 minutes.» Each paper has a maximum of 60 marks.» Minimum mark required for this section is 36 out of 60
Part B: Practical application of learning	<ul style="list-style-type: none">• Workplace Risk Assessment Project Submission<ul style="list-style-type: none">» Learners are required to complete a workplace risk assessment using the standard IOSH form» This is to be completed within two weeks of the end of the course» This paper has a maximum of 38 marks.» Minimum mark required for this section is 23 out of 38

To be eligible for a managing safely certificate, delegates must have a total score of 60 or more
